QSR BRANDS' AYAMAS FOOD CORPORATION SDN BHD AND ALIRAN IHSAN RESOURCES BERHAD SHOWCASE THE WORLD'S FIRST HALAL COMPLIANT WATER RECYCLING PLANT AT MIHAS 2019

KUALA LUMPUR, 3 April 2019 – Aliran Ihsan Resource Berhad and QSR Brands' Ayamas Food Corporation Sdn Bhd (AFCSB) are participating in the Malaysia International Halal Showcase (MIHAS) 2019 under the High Technology (HiTeC) exhibition. The companies' showcase during MIHAS 2019 has drawn special attention from the guests as they showcase the world's first halal compliant water recycling plant for poultry processing.

The showcase is intended to educate, share and explain to the visitors about the successful wastewater upgrading and recycling project at AFCSB's plant in Port Klang, Selangor.

The project was implemented to cater to the expansion of AFCSB's poultry processing plant which has directly increased the capacity of the plant's daily wastewater from 2,000 cubic metres (m³) to 3,000 m³. To address the issue, the wastewater treatment plant was retrofitted with membrane application – a membrane bio-reactor technology. The membrane bio-reactor (MBR) enables the plant to treat more waste water while maintaining the similar foot print area. The membrane application also employs a state-of-the-art filtration with pore sizes down to 0.02 micron. Treating the wastewater with the membrane bio-reactor allows a high quality of effluent discharge into the environment and in compliance with the Department of Health's Standard B. This impressive fast-track project was completed within eight months.

Besides achieving the objective, the project has also introduced a value-added, green initiative element by installing a polishing system that channels recycled water for non-potable usage around the plant. The plant is able to treat 1,300 m³ of effluent in a day using the polishing system. The treated water are distributed around the factory for non-potable

purposes such as washing trucks and floors, gardening and facility landscaping, as well as flushing water in washrooms.

This collaboration between AFCSB and AIR Berhad has set up a new trend in sustainable development efforts, where dependency on water supply is reduced while minimising the effluent discharge into the environment. This effort has been identified as being in line with the Government's recommendation in achieving the country's Sustainable Development Goals.
